### Routing:

**On Friday March 10, 2023, I (Deputy D. Cetin) responded to 1048 Gant Rd, Indian Land, SC, located in Lancaster County in reference to vandalism later determined to be a civil problem. This address is a religious organization of the Islamic Community Center of South Charlotte.**

**Upon my arrival, I spoke to Arshad Knan who stated they were having a playground built for the community. Arshad stated they had a contractor take out the old playground and built a wood foundation on 03/09/2023. Arshad stated when he came to pray today, he noticed the foundation was gone. Arshad stated he does not own the property and it is under a trust. He stated two groups use the community center called Shura but stated he is the president. He stated an individual of the other group told the contractor building the foundation to stop working because he did not have approval. Arshad believes it was the other group who removed the foundation. Arshad stated the other group has access to the cameras and he did not. Arshad showed me a photo of this group's leadership.**

**I then spoke to Mustapha Saoui and Mehdi Majih who are apart of the other Shura group. They stated they hold the power of the community center, and they are in charge. They stated Arshad was not allowed to conduct work on the ground when they did not approve. Mehdi stated they've been to court about similar issues involving who is in power of the community center. Mehdi stated they cannot conduct work without their approval. Mehdi showed me ICCSC website showing their chain of Leadership which aligns with what Mehdi was saying. Mehdi provided court documentation of the ongoing court dilemma from the other Shura group suing them.**

**No crime occurred during this incident. It cannot be determined who is in power of the ICCSC at this time. I advised both groups this was a civil matter and had to be determined in court on their upcoming court date. I advised Arshad to have the court approve any work before starting so there is no further issues.**

**My body-worn camera was activated during this incident.**
