

On March 13, 2023, at approximately 10:00 A.M., Deputy, A. Maniscalco and I, DFC T. Vitek, responded to 1048 Gant Road (Islamic Community Center) in reference to a civil matter. Once on the scene, Deputy Maniscalco and I identified two groups that were having the current conflict. There was also a contractor on scene building the play set, he was identified as Ken Loeffler.

The groups are identified as such:

GROUP 1 Mehdi Wajih - Bouna Cisse - Marlon Haniff GROUP 2

Abdul Mohammed - Masoom Shaik - Suleman Waheed - Ikram Khan - Adnan Jafri

Group 2 is attempting to build a play set at this time due to the number of children that will be at the center in the next few weeks. Subjects with group 1 have voiced objection to this and stated that Group 2 didn't get the proper authorization to have the play set installed. According to both groups, there is an internal power struggle over the community center. According to both parties, there is currently a lawsuit that is still pending in the court system at this time. The subjects of group 1 stated that the subjects of group 2 were intently kicked out and membership was revoked to the center, but they opened a lawsuit against them and have been allowed back to be a part of the center. Both groups were claiming that they had the power to either tell Ken to keep working or not to keep working.

At this time there is not a clear understanding of who is allowed to have people come onto the property to complete work and projects. Due to this, I spoke with Ken and we both came to an agreement that until there is an official court order stating who has power to order projects to be completed, it would be best for him to leave. Ken understood and stated that he would leave at this time.

Subjects of group 2 asked that subjects of group 1 don't touch any of the items of the play set area until court litigation is completed. Subjects of group 1 asked the same for subjects of group 2. Both groups agreed that the play set is a great idea, and both want it added. I advised both groups that it would be beneficial to sit down and have a civil conversation about this and work together. Both groups understood and agreed to that. Due to the nature of the situation, I advised both parties that we would be documenting this in a case report. This has been an ongoing situation for the last couple of months.

This case report will be unfounded due to it being for documentation only. My BWC was activated for the duration of the incident and will be uploaded at the end of shift.
